All clubs are required to bring one qualified judge (for each session) for every three gymnasts competing in JO levels 3 through 10 and ASPIRE.

Schedule / Session groupings will be sent to clubs.

Deadline: Deadline for registration form, athlete's waiver and cheque is **January 15th, 2016.**

Awards: Event and All Around 1st to 3rd medals and 4th to 8th ribbons.
